Arrowhead Business Group: Methesian Youth Entrepreneurship Program Inspiring, Leading, Creating



Dear Interested Participants,

Ya'at'eeh!

I would to share with you some information about the Arrowhead Business Goup Camp that will take place on July 23 through 26, 2018 at the Dine College in Tsaile, Arizona. A similar camp was implemented with the White Mountain Apache Tribe and Johns Hopkins Center for American Indian Health whom received funding from Barclays Bank and the Native American Research Centers for Health (NARCH) to develop, implement, and evaluate an entrepreneurship curriculum that provides youth with practical and effective tools to promote social, occupational, and economic development and build resilience. This program is currently being adapted for Navajo youth in partnership with JHCAIH and Chinle Health Promotion, Methamphetamine Suicide Prevention Initiative (MSPI) for implementation to Navajo Youth.

Background:

- Persistent psychosocial and environmental risks threaten Native adolescents' development.
- Key risk factors are poor attachment to school and hopelessness about the future.
- Assets-based approaches to stimulating Native youths' protective factors against high risk behaviors are scarce.
- Entrepreneurship education increases:
 - motivation to complete formal education
 - o positive life outcomes including security, autonomy, identity, and achievement
 - individual confidence, knowledge, and capacity

Program Design: Arrowhead Business Group (ABG) Youth Entrepreneurship Program is a culturally appropriate entrepreneurship intervention comprised of 16 modules targeting youths' attachment to educational and occupational goals. Curriculum content covers life skills, financial literacy, and business development.

ABG is delivered by Navajo paraprofessional interventionists through a 4 day/3 night summer residential camp and follow-on year-round program in an interactive classroom-style setting to groups of youth with opportunities for real-world skills application and guidance from community leaders and mentors.


Evaluation: ABG is currently being evaluated for long-term impact on: college intention, occupational interest, locus of control, social connectedness, high school attendance, self-efficacy, hopelessness, substance use, depressive symptoms, and other risk-taking behaviors.

A Youth Entrepreneurship, Financial & Life Skills Program

In consideration for participating in any way in the Event, I the undersigned, for myself, or (if applicable) the minor participant child, and for each of our respective "Releasors" (as defined below), agree as follows:

Assumption of Risk: The undersigned hereby acknowledges and agrees on behalf of myself and the minor participant identified above that he/she:

- (a) understands the nature of the Event;
- (b) is in good health, and in proper physical condition to be present at the Event and participate in any and all activities therein;
- (c) knowingly and voluntarily, accepts and assumes responsibility for any risks and dangers that could arise out of, or occur during, his/her presence at and participation in the Event; and
- (d) will comply with any and all on-site directions, guidelines and rules of conduct at the Event, as set forth by Releasees (as defined below) or their representatives.

On behalf of the Releasors, the undersigned agrees that state or federal courts located in Phoenix, Arizona shall have personal jurisdiction over me/us with respect to, and shall be the exclusive forum for the resolution of, any controversy or dispute arising from or relating to this Agreement. The undersigned expressly agrees that this Agreement is intended to be as broad and inclusive as is permitted by law and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: The undersigned has read this Agreement in its entirety, and has had the opportunity to ask questions about the same. The undersigned fully understands that by signing this Agreement and assuming the risks associated with participation in the Event, as well as further agreeing to release, covenant not to sue, waive liability, and indemnify the Releasees, that the undersigned is giving up substantial rights in connection therewith, and that its terms are contractual, and not a mere recital.
