
Q1 Overall, how clear was the information presented at "Assessment Days"?









Q3 Was there enough time for discussion on "Identifying barriers and facilitators to assessment across all programs"?






Q5 Was there enough time to work on rubric creation?

Q6 Did the workshop improve your understanding of program assessment?






